**RESOLUTION ---- AWARDING BID TO CONCRETE RESTORATION SPECIALISTS, LLC,  
FOR THE SURFACE REPAIR OF THE STATE STREET BRIDGE PROJECT, STR#SA 20-  
5.15 - OPWC CEW15**

The Board of County Commissioners, Sandusky County, Ohio, met in regular session on the 21<sup>st</sup> day of August, 2012 at the offices of the Board with the following members present:

Commissioner Damschroder moved the adoption of the following resolution:

**Whereas**, pursuant to the County Engineer requesting same, bid proposals were received on 08.16.2012 for the aforementioned project, and,

**Whereas**, the Board of Commissioners in conjunction with the County Engineer, after review of the bids, finds the lowest and best bid to have been offered by Concrete Restoration Specialists, LLC, and,

**Whereas**, a search of the Auditor of State database finds no finding for recovery levied against the aforementioned company, and,

**Whereas**, the County Engineer, has recommended that the award be made to Concrete Restoration Specialists, LLC, in the amount of \$435,405.00.

**THEREFORE; Be It Resolved,**

Section 1. The Sandusky County Board of Commissioners authorizes that the bid award for the State Street Bridge surface repair project, STR#SA 20-5.15, OPWC CEW15, be made to Concrete Restoration Specialists, LLC. The award amount is \$435,405.00.

Section 2. This resolution shall be copied to Concrete Restoration Specialists, LLC, P.O. Box 283, Sharon Center, OH. 44274, to the County Engineer's office and to Norman Solze, Assistant Prosecutor.

Section 3. All unsuccessful bidders shall have their bid bonds and/or bid bond checks returned at this time.

Section 4. It is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were so adopted in an open meeting of this Board, and that all formal actions, were in meetings open to the public, in compliance with all legal requirements.
