

SINGLE COUNTY DITCH PETITION

Revised Code, Secs. 6131.04; 6133.02, .03

Sandusky County, Ohio, Feb 11, 2014

To the Board of County Commissioners, Sandusky County, Ohio:

The undersigned hereby petitions your honorable body ... for an improvement in a manner deemed to be most conducive to public welfare of the watercourse to be known as the Miller Tile utilizing any, all or a combination of the methods provided in Ohio Revised Code Section 6131.01 (C) (1) (2) (3) (4) (5) necessary for the disposal of surplus water.

The construction of the improvement is necessary, will benefit the petitioner(s), and will be conducive to the public welfare.

The following is the course and termini of said proposed improvement, to-wit: The proposed project begins on the north side of Township Road 183 (aka as Mt. Carmel Road) at the existing 12" crossover (GR 183-0.04), approximately 1500' east of the northwest corner of Section 35 of Green Creek Township; Thence south under TR 183 approximately 200'; Thence in a south-westerly direction approximately 2400' to the existing 60" culvert (GR 195-3.12) under Township Road 195 (aka as Galetown Road) where a sufficient outlet is provided and the project will terminate.

All costs of engineering, construction, and future maintenance will be assessed to the benefitting parcels of land, except as ordered under Section 6131.31 of the Revised Code.

The following is the nature of the work petitioned for: Reconstruction of the existing watercourse or construction of a new watercourse utilizing open ditch and/or pipe to make the channel adequate to serve it's watershed as is reasonable and feasible.
