

RESOLUTION 2015 - 140

**RESOLUTION ---- AWARDING BID TO MACK INDUSTRIES, INC., OF BOWLING GREEN, OHIO, FOR 2015 SUPPLYING PRECAST REINFORCED CONCRETE BOX CULVERT FOR STR. GR 223-1.78**

The Board of County Commissioners, Sandusky County, Ohio, met in regular session on the 12<sup>th</sup> day of May, 2015 at the offices of the Board with the following members present:

Commissioner Thatcher moved the adoption of the following resolution:

**Whereas**, pursuant to the County Engineer requesting same, bid proposals were received on 11.30.2015 for the aforementioned supplying precast reinforced concrete box culvert for str. Gr 223-1.78,

**Whereas**, the Board of Commissioners in conjunction with the County Engineer, after review of the bids, finds the lowest and best bid to have been offered by Mack Industries, Inc., and,

**Whereas**, a search of the Auditor of State database finds no finding for recovery levied against the aforementioned company and furthermore finds no debarment issue, and,

**Whereas**, the County Engineer, has recommended that the award be made to Mack Industries, Inc. in the amount of \$33,948.00,

**THEREFORE; Be It Resolved,**

Section 1. The Sandusky County Board of Commissioners authorizes that the bid award for supplying precast reinforced concrete box culvert for str. Gr 223-1.78 be made to Mack Industries, Inc., of Bowling Green, Ohio. The award amount is \$33,948.00.

Section 2. This resolution shall be copied to Mack Industries, Inc., 507 Derby Street, Bowling Green, Ohio 43402, to the County Engineer's Office and to Norman Solze, Assistant Prosecutor.
