

RESOLUTION 2015 - 138

RESOLUTION --- AWARDING BID TO NORTHERN CONCRETE PIPE, OF SYLVANIA OHIO, FOR 2015 SUPPLYING PRECAST REINFORCED CONCRETE CIRCULAR PIPE AND MANHOLE FOR STR. YO 177-0.11

The Board of County Commissioners, Sandusky County, Ohio, met in regular session on the 12th day of May, 2015 at the offices of the Board with the following members present:

Commissioner Schwochow moved the adoption of the following resolution:

Whereas, pursuant to the County Engineer requesting same, bid proposals were received on 11.30.2015 for the aforementioned 2015 supplying precast reinforced concrete circular pipe and manhole for str. Yo 177-0.11, and,

Whereas, the Board of Commissioners in conjunction with the County Engineer, after review of the bids, finds the lowest and only bid to have been offered by Northern Concrete Pipe, and,

Whereas, a search of the Auditor of State database finds no finding for recovery levied against the aforementioned company and furthermore finds no debarment issue, and,

Whereas, the County Engineer, has recommended that the award be made to Northern Concrete Pipe in the amount of \$41,288.00,

THEREFORE; Be It Resolved,

Section 1. The Sandusky County Board of Commissioners authorizes that the bid award for 2015 supplying precast reinforced concrete circular pipe and manhole for str. Yo 177-0.11 be made to Northern Concrete Pipe of Sylvania, Ohio. The award amount is \$41,288.00.

Section 2. This resolution shall be copied to Northern Concrete Pipe, 3756 Centennial Rd. Sylvania, Ohio 43560, to the County Engineer's Office and to Norman Solze, Assistant Prosecutor.

Section 3. It is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were so adopted in an open meeting of this Board, and that all formal actions, were in meetings open to the public, in compliance with all legal requirements.
