

RESOLUTION 2014 - 387

**RESOLUTION ---- AWARDING BID TO PRESTRESS SERVICES INDUSTRIES, LLC, OF LEXINGTON, KY., FOR THE 2015 MANUFACTURE, STORAGE, DELIVER AND ERECTION OF A PRESTRESSED CONCRETE BRIDGE SUPERSTRUCTURES**

The Board of County Commissioners, Sandusky County, Ohio, met in regular session on the 23<sup>rd</sup> day of December, 2014 at the offices of the Board with the following members present:

Commissioner Thatcher moved the adoption of the following resolution:

**Whereas**, pursuant to the County Engineer requesting same, bid proposals were received on 11.25.2014 for the aforementioned bridge superstructures for MA 66-1.10 and SC 32-0.19, and,

**Whereas**, the Board of Commissioners in conjunction with the County Engineer, after review of the bids, finds the lowest and best bid to have been offered by Prestress Services Industries, LLC, and,

**Whereas**, a search of the Auditor of State database finds no finding for recovery levied against the aforementioned company and furthermore finds no debarment issue, and,

**Whereas**, the County Engineer, has recommended that the award be made to Prestress Services Industries, LLC in the amount of \$134,800.00,

**THEREFORE; Be It Resolved,**

Section 1. The Sandusky County Board of Commissioners authorizes that the bid award for the 2015 manufacture, storage, delivery and erection of a prestressed concrete bridge superstructures for MA 66-1.10 and SC 32-0.19 be made to Prestress Service Industries, LLC, of Lexington, Ky. The award amount is \$134,800.00.

Section 2. This resolution shall be copied to Prestress Service Industries, LLC- 216 Fountain Court - Lexington, KY. 40555, to the County Engineer's Office and to Norman Solze, Assistant Prosecutor.

Section 3. It is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were so adopted in an open meeting of this Board, and that all formal actions, were in meetings open to the public, in compliance with all legal requirements.
