Main St., Woodville, Ohio 43469 until 7:00 p.m. on the 16th day of March, 2016 for the furnishing all labor, materials and equipment necessary to complete the project known as 2016 Township Roads Resurfacing Project at said time and place they will be publicly opened and read aloud.

Proposals must be submitted on the forms furnished or downloaded from above website and must contain the name of every person interested therein. The Proposal shall be accompanied by a Bid Guarantee and Contract Bond in the amount of 100% of the amount bid or a Certified or Cashier's Check or a Letter of Credit in an amount of at least 10% of the amount bid. The Board reserves the right to reject any or all bids and to waive any formalities in any bid. Each bidder must submit evidence of its experience on projects of similar size and complexity.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their product. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, Governor's Executive order of 1972, and Governor's Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wages rates on Public Improvements in Sandusky County as determined by the Department of Industrial Compliance and Labor. The completion date for the 2016 Township Roads Resurfacing Project is September 30, 2016.
