

JOINT COUNTY DITCH PETITION

Revised Code, Secs. 6131.04; 6133.02, .03

Sandusky County, Ohio, Jan. 22, 2009

Petition to Clean the Alley Ditch.

To the Joint Board of County Commissioners, Sandusky and Seneca Counties, Ohio:

The undersigned hereby petition your honorable body to clean the Alley Ditch on the course hereinafter set forth.

The construction of the improvement is necessary, will benefit the petitioner(s), and will be conducive to the public welfare.

The following is the course and termini of said proposed improvement, to-wit:

The Alley Ditch begins at a point on the existing open ditch approximately 825 feet north and 250 feet west of the SE corner of Seneca County Parcel No. N46000747600000, Section 5, Thompson Township, Seneca County, T3N R17E; thence continues in a Northerly direction for approximately 500 feet; thence turns and follows a Westerly direction for approximately 2,500 feet, crossing under Thompson Township Road 79; thence continuing in a Northwesterly direction for approximately 6,350 feet before crossing under Thompson/Adams Township Road 78; continuing in a Northwesterly direction for approximately 3,450 feet before reaching the Seneca/Sandusky County Line; crossing under Seneca County Road 62 (aka Sandusky County Road 113); thence turning and continuing in a westerly direction for approximately 1,500 feet along the north side of said road; thence turning and continuing in a Northwesterly direction for approximately 600 feet; thence turns and continues in a Northerly direction for approximately 500 feet, crossing under Sandusky County Road 177; thence turns and continues in a Northeasterly direction for approximately 800 feet; thence turns and continues in a Northerly direction for approximately 225 feet; thence turns in a Northeasterly direction for approximately 1,500 feet; thence turns in a Northerly direction for approximately 1,900 feet; thence turns in a general Northeasterly direction for approximately 2,700 feet and terminates at the junction with Raccoon Creek in Section 36 Green Creek Township, Sandusky County.
