**AWARDING BID TO M&B ASPHALT CO. INC., OLD FORT, OHIO, FOR THE 2019
RESURFACING PROJECT OF CR 229 AND CR 239**

Whereas, pursuant to the County Engineer requesting same, bid proposals were received on December 6, 2018 for the aforementioned CR 229 and CR 239 resurfacing and,

Whereas, the Board of Commissioners in conjunction with the County Engineer, after review of the bids, finds the lowest bid to have been offered by M&B Asphalt Co. Inc., and,

Whereas, a search of the Auditor of State database finds no finding for recovery levied against the aforementioned company and furthermore finds no debarment issue, and,

Whereas, the County Engineer, has recommended that the award be made to M&B Asphalt Co. Inc., of Old Fort, Ohio in the amount of \$971,839.00.

THEREFORE; Be It Resolved,

Section 1. The Sandusky County Board of Commissioners authorizes that the bid award for Resurfacing of CR 229 and CR 239 be made to M&B Asphalt Co. Inc., The award amount is \$971,839.00

Section 2. This resolution shall be copied to M&B Asphalt Co. Inc., Old Fort, Ohio to the County Engineer's Office and to Mark Mulligan, Assistant Prosecutor.


Dear Commissioners:
