Sealed Proposals will be received by the Sandusky County Board of Commissioners, 622 Croghan Street, Fremont, Ohio 43420 until 10:30 AM on February 27, 2020 for the furnishing of all labor, materials and equipment necessary to complete the projects known as the County Road 177 Improvements; Various County Road Improvements; and County Road 89, County Road 106, and Linden Avenue (Gibsonburg) Resurfacing at said time and place they will be publicly opened and read aloud.

Proposals must be submitted on the forms furnished or downloaded from the above website and must contain the name of every person interested therein. The Proposal shall be accompanied by a Bid Guarantee and Contract Bond in the amount of 100% of the amount bid or a Certified or Cashier's Check or a Letter of Credit in an amount of at least 10% of the amount bid. The Board reserves the right to reject any or all bids and to waive any formalities in any bid. Each bidder must submit evidence of its experience on projects of similar size and complexity.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their product. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, Governor's Executive order of 1972, and Governor's Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in, Sandusky County, pursuant to the Department of Industrial Compliance and Labor. The completion date for the County Road 177 Improvements, and the County Road 89, County Road 106, and Linden Avenue (Gibsonburg) Resurfacing is September 30, 2020. The completion date for the Various County Road Improvements is October 15, 2020.
