

RESOLUTION 2021 - 174

AWARDING BID TO HENRY W. BERGMAN, INC. OF GENOA, OHIO FOR THE 2021 CR 44, TWP RD 139 (WOODVILLE), & EAST YEASTING ROAD (GIBSONBURG) RESURFACING PROJECT

The Board of County Commissioners, Sandusky County, Ohio, met in regular session on the 18th day of May, 2021 at the offices of the Board with the following members present:

Whereas, pursuant to the County Engineer requesting same, bid proposals were received on May 4, 2021 for the aforementioned 2021 Resurfacing Project, and,

Whereas, the Board of Commissioners in conjunction with the County Engineer, after review of the bids, recommends the bid be awarded to Henry W. Bergman, Inc. of Genoa, Ohio, and,

Whereas, a search of the Auditor of State database finds no finding for recovery levied against the aforementioned company and furthermore finds no debarment issue, and,

Whereas, the County Engineer, has recommended that the award be made to Henry W. Bergman, Inc., Genoa, Ohio in the amount of \$339,900.00.

THEREFORE; Be It Resolved,

Section 1. The Sandusky County Board of Commissioners authorizes that the bid award for the 2021 CR 44, Twp. Rd 139 (Woodville), & East Yeasting Road (Gibsonburg) Resurfacing Project be made to Henry W. Bergman, Inc. of Genoa, Ohio. The award amount is \$339,900.00
