

RESOLUTION 2022 - 194

AWARDING BID TO KOKOSING CONSTRUCTION CO. INC. OF ELYRIA, OHIO, FOR THE 2022 CR 128 & CR 130 IMPROVEMENT PROJECT, OPWC PROJECT NUMBER DEZ49

The Board of County Commissioners, Sandusky County, Ohio, met in regular session on the 12th day of July, 2022 at the offices of the Board with the following members present:

Commissioner Zimmerman moved the adoption of the following resolution:

Whereas, pursuant to the County Engineer requesting same, bid proposals were received on March 10, 2022 for the aforementioned CR 128 & CR 130 Improvement Project, OPWC Project Number DEZ49 and,

Whereas, the Board of Commissioners in conjunction with the County Engineer, after review of the bids and based on the recommendation of the Sandusky County Prosecutor, Beth Tischler, finds the second lowest bid offered by Kokosing Construction Co. Inc., to be the best bid, and,

Whereas, a search of the Auditor of State database finds no finding for recovery levied against the aforementioned company and furthermore finds no debarment issue, and,

Whereas, the County Engineer, has recommended that the award be made to Kokosing Construction Co. Inc. of Elyria, Ohio in the amount of \$1,084,984.75

THEREFORE; Be It Resolved,

Section 1. The Sandusky County Board of Commissioners authorizes that the bid award for CR 128 & CR 130 Improvement Project, OPWC Project Number DEZ49 be made to Kokosing Construction Co. Inc. of Elyria, Ohio in the amount of \$1,084,984.75

Section 2. This resolution shall be copied to Kokosing Construction Co. Inc. of Elyria, Ohio, to the County Engineer's Office and to Beth Tischler Sandusky County Prosecutor.
